### PROHIBITING MOTOR VEHICLES ON SIDEWALKS

#### Section 1: Legislative intent.

The Village Board of Franklin has become aware of the operation of snowmobiles and other motor vehicles on Village sidewalks and upon other Village property. Since the operation of unlicensed motor vehicles of any kind on streets or highways is in violation of the Vehicle and Traffic Laws of the State of New York and in consideration of the health, safety, and general welfare of the residents of the Village of Franklin, the Board finds that these actions should also be prohibited within the Village.

#### Section 2: Prohibited acts.

No person shall operate any motorized vehicle upon any Village sidewalk, and no licensed motor vehicle shall be operated upon any Village property, except upon a Village owned roadway or within a designed parking area located on Village property.

**Section 3: Exceptions.**

This law shall not apply to motorized chairs designed for handicapped persons, battery operated children's toys, or to lawn mowing or garden tractors when being used for maintenance purposes.

**Section 4: Penalties for offenses.**

Each violation under this article shall constitute a separate offense. Any person who violates this article shall be punished by a fine of a maximum of \$250 for each offense.

**Section 5: Severability.**

In the event that any word, phrase or part of this local law shall be declared unconstitutional, the same shall be severed and separated from the remainder of this local law and shall not affect the remainder of said local law which shall remain in full force and effect.

**Section 6: Effective Date.**

This local law shall take effect upon filing with the Secretary of State as required by law.
