#### Local Law No. 1 of the year 2022

A local law adopted pursuant to Cannabis Law § 131 opting out of on-site cannabis consumption establishments within the Village of Franklin, NY.

#### Section 1. Legislative Intent

It is the intent of this local law to opt the Village of Franklin out of hosting on-site cannabis consumption establishments within its boundaries.

#### Section 2. Authority

This local law is adopted pursuant to Cannabis Law § 131, which expressly authorizes cities and villages to opt-out of allowing on-site cannabis consumption establishments to locate and operate within their boundaries.

## Section 3. Local On-site Cannabis Consumption Establishments Opt-Out

The Board of Trustees of the Village of Franklin, County of Delaware, hereby opts-out of allowing on-site cannabis consumption establishments from locating and operating within the boundaries of the Village of Franklin.

#### Section 4. Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the

clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

### Section 5. Effective date

This local law shall take effect immediately upon filing with the Secretary of State.

This local law was approved by voter referendum on March 15, 2022, and shall take effect immediately upon filing with the Secretary of State.
